Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.  ◆ Our affiliates include:  ◆ Companies with a German American Bank name including GABC Leasing, Inc.; and financial companies such as an investment services company.		
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.  • German American Bank does not share with nonaffiliates so they can market to you.		
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • German American Bank doesn't jointly market.
